| | If you wish to use funding without paying for the extras charge/using private hours with the Nest, we provide funding on a stretched basis over 51 weeks of the year. | | | | | | |
| | For 15 hours places, this is 11 per week over 51 weeks, we offer Friday 8-6, which is 10 hours on one day. Unfortunately providing 1 hour on another day alongside this is not feasible. | | | | | | |
| | For 30 hours places, we can provide Friday 8-6 along with two 5 hour half-days that are available at the time. As we only offer full-days and half-days privately, it's important to the Nest that these free places do not create a lower tier of care for the parents or children using this arrangement. | | | | | | |
